Minutes of 3rd Academic Council Meeting

Held on 20th Oct. 2022 at Workshop Hall in KLS IMER Belagavi from 11.30 am to 1.30 pm

The following agenda of the meeting was taken up for discussion -

1. Review of the minutes of the previous meeting and compliance:

Dr. Shrinivas R Patil presented the compliance report of the minutes of the 2nd Academic Council meeting held in September 2021. The members noticed and appreciated the efforts of the Institute to comply with all points raised during the last meeting. Accordingly, the Compliance Report was approved by the Council.

2. Examination Result Updates:

Prof. Shrirang Deshpande, DCOE updated the council regarding the results of MBA I Sem, II Sem. and III Sem. The AC members suggested to improve the presentation of the result analysis to reflect the following

- Analyze the results based on semester-wise, caste-wise, gender-wise, percentage-wise.
- Nature of the course (core, electives OPE etc) & the respective passing percentage.
- Members further suggested to have remedial/bridge courses in respective courses for improvement.

3. Approval of Revised MBA Program Structure from AY 2022-23 onwards

Dr. Sushil Kumar Pare, Professor presented detailed information on the Revised Program Structure. The committee appreciated the effort of the team and suggested the following points;

- To introduce the Business Research Methods course to the Second Semester and Data Analysis for the First Semester.
- AC member suggested to present the MBA program structure based on AICTE/UGC (Template). They further suggested to reconsider the credits of certain theory courses like Principles of Management, and introduce two courses namely OB and HRM separately with 2 credits each instead of combining both courses.
- AC suggested to reconsider the nomenclature of SERI project.
- AC agreed upon the proposal to reduce the duration of semester end examinations from 3 hrs to 2 hrs for 60 marks paper. AC agreed to adopt the semester end examinations question paper pattern presented during the meeting.
- Academic Council approved the proposed revised program structure from Academic year 2022-23 onwards.

4. Updates on IQAC

Dr. Shailaja Hiremath updated the members on the development of IQAC. AC suggested to prepare a plan of action for enhancing the NAAC grade from coming academic year. AC suggested to Organize workshop/seminar on NEP 2020 & invite experts for the better understanding of NEP 2020 implementation.
