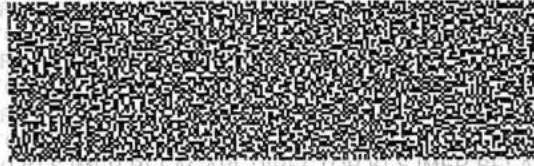

SCOPE OF THE MOU

KLS’ Institute of Management Education and Research, Belagavi (henceforth called KLS IMER) and Green Saviours Association have agreed that in support of their mutual interests in the field of education and development hereby enter into this MOU to enable **KLS IMER** to provide said services/program.

KLS IMER shall extend the use of the following Resources and Facilities, and Collaborations to Green Saviours Association:

- 1. Collaboration to conduct Events/Programmes wherever possible to enhance the mutual learning and development of both parties.
- 2. To provide the students of IMER to work in live projects, Internships etc. as per academic requirements.

GREEN SAVIOURS ASSOCIATION will provide **KLS IMER (faculty and students)** the opportunity to interact and learn from the entrepreneurial experience of its members.

- 1. Engage students in organizing events of Green Saviours Association so that students can learn event management skills
- 2. Encouraging environmentalists from the known network of Green Saviours Association, to interact with faculty and students of IMER so that there can be mutual learning and sensitization about environmental issues.
- 3. Providing learning opportunities to faculty and students through internships, projects, etc.
